### Investment policy

The sub-fund invests between 70% and 100% of its assets in participation units of the fund UniEM Fernost managed by Union Investment Luxembourg S.A.

The remaining part of deposits can be invested in assets permitted by the fund statute, such as: equities, warrants, debt securities, money market instruments and deposits. At least 2/3 of the Master Fund assets is invested in equities and other types of equity securities of companies from the Far East (e.g. companies from China, Taiwan, Korea, India and Indonesia).

### Investor profile

The sub-fund is addressed to investors, who:

- are interested in investing in dynamic and emerging markets from Far East,
- are looking for alternatives to polish equities as well as to developed countries equities,
- have at least 6 years investment horizon,
- understand the sub-fund's high investment risk and possible fluctuations of the value of invested assets.

The sub-fund is not addressed to investors, who:

- look for guaranteed profit,
- do not accept either the fluctuations of the value of invested assets in short-term period nor the high investment risk,
- invest only in short-term period.

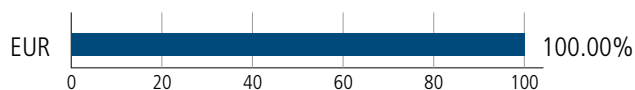

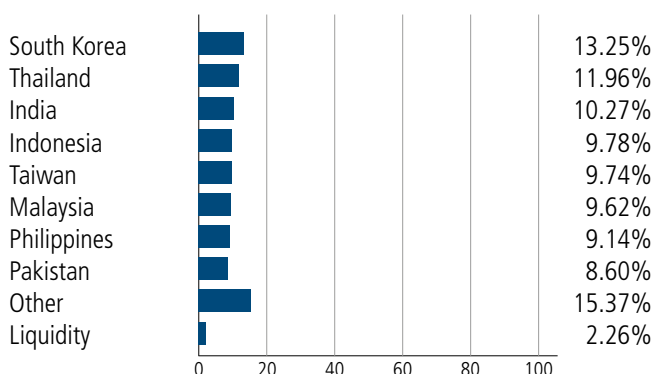

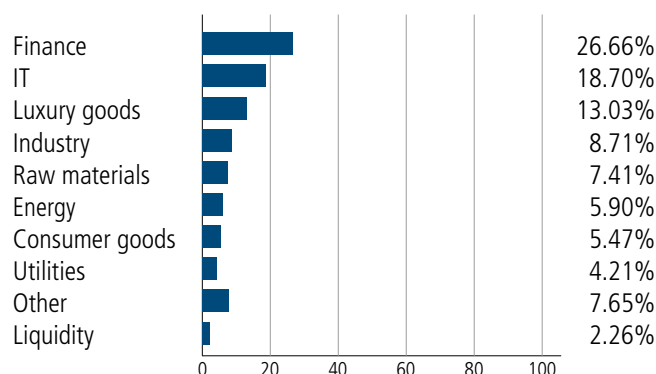
