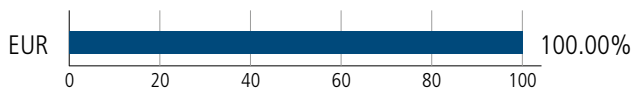

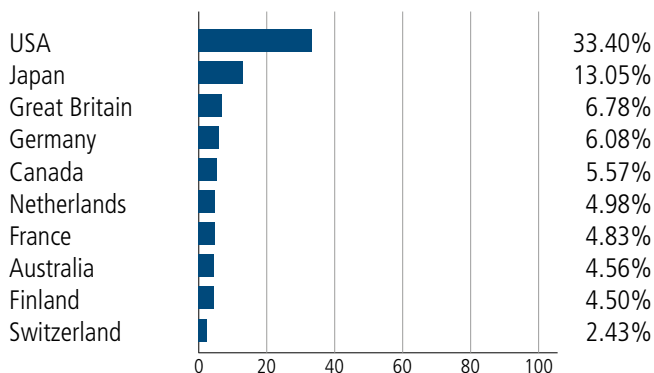

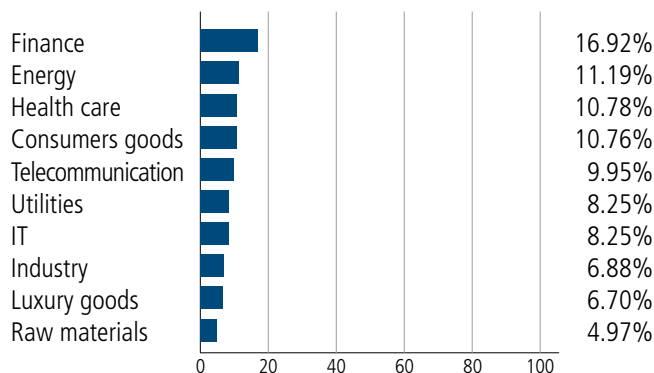
## Master Fund – UniInstitutional Global High Dividend Equities
